As we finish getting through another winter, please know that while it might seem quiet in BFHA land, it has been anything but! Your all-volunteer Executive Committee has been very active in the last couple of months. We've met with Elected Officials and new homeowners regarding Land Use (including the proposed "Pedestrian Plaza" near 156th Street and Northern Boulevard) and building issues including a proposed art and cultural Buddhist Temple in the area. We've monitored the renovation of houses with the DOB, and aided our neighboring Civic Associations with their own struggles. The Executive Committee also fights for a reduction in airplane noise, and has a special committee that fought for landmarking by the city. Because we recently received a letter from the Landmarks Preservation Commission denying Broadway-Flushing Historic District Status, we are working closely with our elected officials on a proposal for the creation of a "Contextual/Architectural District" that would require new buildings to conform substantially with present homes as a way of protecting the open and suburban character of the neighborhood. Once again the Bowne Tree Lighting was a big success! Great showing of community and holiday cheer. Thanks to all who attended this fun event.



We had an extremely well attended Landmark Rally in January with 200+ in attendance. We continue to work with all elected officials, and every option will be explored to preserve and protect our uniquely beautiful neighborhood. Unfortunately, the LPC sent us a letter explaining why we do not qualify as a Historic District. However, Senator Avella is planning to introduce a new Bill that will allow us to petition NY City Planning for a special architectural district designation. We will continue to work with Councilmember Vallone, DOB, City Planning and all of our elected officials until Broadway Flushing is granted the protection it deserves!
